The Town elector meeting will be held immediately following the completion of the Public Hearing on the proposed 2021 Town budget which begins at 7:00 p.m. for the following purposes:

1. To consider the adoption of a resolution by the town meeting endorsing a town board resolution which proposes that the town levy exceed the state allowable levy limit under s. 66.0602 of Wis. Statutes, specifically a proposed tax levy which would exceed the allowable town tax levy for 2020 by **10.9%** percent which would be a dollar increase of **\$89,615** (the amount for Debt Service and Interest).

2. To approve the total 2021 highway expenditures pursuant to s. 81.01(3) of Wis. Statues. --- §713,340.

3. To approve the 2020 total town tax levy to be collected in 2021 pursuant to s. 60.10(1)(a) of Wis. Statutes. which would be <u>\$698,500</u> plus Milltown Fire Association assessment of \$67,250.
