ORDINANCE NO. 196

AN ORDINANCE TO REGULATE PARKING, HOURS, AND ACTIVITIES AT THE PUBLIC ACCESS IN THE PLAT OF GREEN BAY OF HALF MOON LAKE IN SECTION 25 T35N 17R OF MILLTOWN TOWNSHIP, POLK COUNTY, WISCONSIN, AND PRESCRIPTING PENALTIES FOR VIOLATION THEREOF.

The Town Board of the Town of Milltown, Polk County, Wisconsin, do ordain as follows:

Section 1. APPLICABILITY AND EMFORMATION. The provisions of this ordinance shall apply to the fublic Access in the Green Bay Plat of Half Moon Lake and surrounding area within the jurisdiction of the Town of Milltown, County of Polk, Wisconsin.

The provisions of this ordinance shall be enforced by the Polk County Sheriff Department, along with any and all other state and county officers authorized by law to enforce the same.

Section 2. (1) PARKING. A parking area will be provided extending from the Easternly boundary of the access on the lakeside to a point approximately 141 feet to the West along the Town Road.

Parking will be prohibited in any other area.

(2) FENCING. A fence will be erected by the land owners marking the boundary of the parking area and private property, also a fence marking the boundary of the access.

Tresspassing will be prohibited on any private property.

Section 3. SPEED LIMIT TO BE REASONABLE AND PRUDENT. The speed limit will be not over 25 MPH at anytime.

Section 4. ACCESS HOURS. The access will be closed from 10:00 PM to 7:00 AM everyday with no exceptions.

Section 5. LIFTERING AND ABUSIVE LANGUAGE.

- (1) No person shall deposit, place or throw any cans, papers, bottles, debris, refuse, garbage, solid or liquid waste unto the access or any private property or the town road, or into the lake.
- (2) No abusive, foul, profane, or unreasonably loud language will be used so that it disturbs, or annoy the private property owners.

Section 6. PENALTIES AND DEPOSITS. Any person who shall violate the provisions adopted by this ordinance shall, upon conviction thereof, forfeit not less than \$10 nor more than \$200, together with the cost of prosecution, and in default of the payment of such forfeiture and costs, shall be imprisoned in the County Jail until the full payment thereof is made, but not exceeding 90 days.

This ordinance shall be in full force and effect from and after one week from the date of passage and posting of this ordinance and proof of such posting is filed in the town records by the Town Clerk.

The foregoing ordinance was adopted at a regular neeting of the Town Board of the Town of Milltown on June 11, 1980.
