- d. Cathy McIntrye buying lot on Little Pine. Would like to know the restrictions on lot, camper, buildings, etc. Clerk will notify her to contact the County for these items. Let Gary Lilyquist know who misinformed Cathy of this information.

Antler Lake – Bergh property. Paul Maher, attorney for Town of Milltown, sent letter stating the fence remains and is the property line per survey.
